Rorschach Performance Assessment System (R-PAS)

4-Day Basic Workshop (3-Day Basic Workshop optional with experience and homework) Donald J. Viglione, Jr., Ph.D., A.B.A.P.

This R-PAS workshop is designed for participants with no previous Rorschach training and those experienced in the Comprehensive System. It provides a thorough, "hands on," introduction to the R-PAS. Participants can expect to learn R-PAS administration, coding, and interpretation through lecture presentations and interactive experiences.

The workshop will have a mixed schedule, with new learners attending all four days of training. Experienced Rorschach users will attend days two through four. Nevertheless, experienced users would benefit from attending the first day. Skipping the first day is feasible for experienced participants who complete the preworkshop homework.

All participants should bring a Manual to the workshop. Pre-workshop reading assignments are found in the R-PAS Manual (*The Rorschach Performance Assessment System, Administration, Coding, Interpretation and Technical Manual,* [Meyer, Viglione, Mihura, Erard, & Erdberg, 2011]). After registering for the workshop a 10% discount code will be forwarded to you so that you can order the Manual. In addition, all participants will receive one free protocol processing on r-pas.org. A one hour follow up conference phone call will be set up to assist in implementing skills learned in the workshop.

- Participants who are new to the Rorschach are expected to read Chapters 1 and 2 of the R-PAS Manual before attending.
- Participants with recent or substantial experience with previous Rorschach systems who wish to join the workshop on Day 2 must prepare by reading Ch. 3 and reviewing Appendices B, C and D (pp. 492-497) in the R-PAS Manual. In addition, these participants need to study the scoring and verbalizations in Case#1, which will be provided.
